The IMO Bookshelf is IMO Publishing's free new e-reader software. E-reader files are available for all major titles in English with some in French and Spanish. They are exact copies of the printed title and can be viewed instantly after purchasing a licence code and downloading the software.

E-reader files are presented in a digital format and include the following key features:

- Installation available without internet access
- Multiple advanced search facilities
- Add your own bookmarks
- Add your own annotations
- Resize font
- Printing
- Copy and paste

Carriage compliance

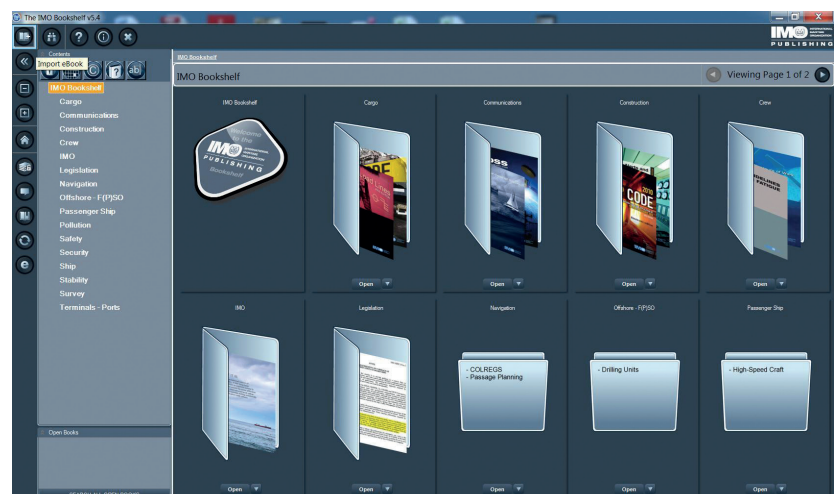
- Complies with IMO requirements on carriage of publications on board ships (MSC-MEPC.2/Circ.2, 1 June 2006):
"The publications may be carried in the form of electronic media such as CD-ROM in lieu of hard copies. Acceptable publications in electronic form should be those issued by IMO or

an Administration or a body authorized by an Administration to ensure correctness of their contents and to safeguard against illegal copying."

- Many Flag States have issued guidance on the carriage of digital products.
- It's the shipowner's responsibility to check the Flag State approval.

The IMO ebook is delivered with one back-up license. This back-up license is to be used if the computer crashes, updates or changes. Once the backup license has been used and the IMO ebook needs to be installed again you will need to purchase an extra unlock for the license which is offered at a 50% discount.

How does it work?

Application

The software is available in two ways:

- Free download from IMO Publishing's website (www.imo.org > Publications > The IMO Bookshelf). This is just the e-reader software without any of the titles added. Purchased digital titles must also be downloaded and unlocked before they can be viewed.
- Free CD which contains the e-reader software and all major e-reader titles available to search and ready for unlocking. You can request a CD at Datema digital department: digital@datema.nl

License period

- License per eBook
- Every eBook has its own due date

Updating

- Software indicates if new version is available
- Errata and supplements are included

Recommendations by Datema

- We advise a phased transition from paper to digital: transfer to digital version when the paper version expires. The result: no additional investment cost.
- We offer the possibility to manage the transition to the eBooks in the Datema Automatic Supply: we take care of your outfit.
- Compliance with the regulations of the various Flag States is the responsibility of the captain/shipowner.

Note:

All IMO e-books are statutory approved for use as a publication on board. However, there are two publications that are required to have on board as a paper version in addition to the digital version.

This concerns: IMO 994 and IMO 962.
